FILM DISTRIBUTOR PRESENTATIONS

To register for the Australian International Movie Convention (AIMC) you must agree to the following Terms & Conditions in relation to attendance at any film distributor presentations conducted within the AIMC program.

The publication of all reviews related to any feature films or trailers shown by the film distributors at the AIMC must be held until the appropriate dates and may not be released until you have received written confirmation from the relevant distributors themselves.

By attending any AIMC screenings and product presentations, you agree on behalf of yourself, your guest(s) and on behalf of the publication/outlet you are representing, to the official review embargo:

1. For daily and weekly publications in all media, including television and radio and online
2. For monthly publications
3. With your attendance you consent that you will not publish any reports or reviews in print, TV, radio or online (including Web Log 'Blogging', Forums, Twitter or Online Chats) as per the above embargo.

If you register for the AIMC and attend any screenings, you accept accordingly on behalf of yourself, the outlet(s)/companies you represent and any guest(s) you may bring, that you will not break the standard embargo, or assist any other party to do so.

We thank you for your co-operation and understanding.

PRIVACY STATEMENT

Your name and organisation may be published on the delegates list which is provided to delegates, exhibitors and sponsors.

Your name and contact information may be used by parties directly related to the event such as approved stakeholders and sponsors.

REGISTRATION TRANSFERS

Substitutions are only allowed with the permission of the original registrant.

A substitution is a straight transfer of registration credentials with no adjustment to the registration category or payment. Requests for a straight substitution received prior to 3 August will be honoured free of charge. Requests received after 3 August will be subject to an additional processing fee of AUD \$77 (inc GST).

If a change to the registration category or payment is required, there will be an additional processing fee of AUD \$77 (inc GST).

Credit card refunds will be issued back to the original credit card upon approval.
